Please note that a designated officer-in-charge should fill in the required details of the above-related application to ensure a high level of accuracy.

Please strictly adhere to the same and inform relevant officials in this regard and take necessary actions.

Please also note that all the requirements mentioned in the previous correspondence in this regard remain the same and the Higher Educational Institutes/Institutions are requested to submit duly filled application forms and other documents as per the checklist when emailing to UGC, to avert any delays in processing the visa applications.
